### 4) FIRST AID MEASURES

#### 10) STABILITY AND REACTIVITY

##### **Skin irritation:**

##### **Sensitisation:**

#### Chronic:

Repeated absorption of relatively large amounts of 2,4-D presents a risk to liver and kidneys.

Repeated absorption of relatively large amounts of dicamba may cause myotoxic muscular spasms, urinary incontinence and, if excessive, dyspnea, cyanosis and exhaustion.

No information currently available on chronic effects of mecoprop.

**Dicamba** - loss from soil primarily by microbial degradation.

**Identified harmful effects on environment:**

Low toxicity to birds, fish, bees and earthworms.

**Other precautions:**

Do not contaminate dams, waterways or sewers with this product.

#### 13) DISPOSAL CONSIDERATIONS

This product should not be allowed to enter drains, water courses or the soil. Do not contaminate ponds, waterways or ditches with chemical or used containers. Triple or preferable pressure rinse containers before disposal. Add rinsings to the mixing tank. Do not dispose of undiluted chemical on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots.
