**GENERAL INSTRUCTIONS:**

Tru-Blue Spray Indicator is only suitable for mixing with water-based spray solutions. Follow mixing instruction on the label of the pesticide or fertiliser product and unless indicated differently, add Tru-Blue Spray Indicator last to the spray tank.

Suggested uses include:

- Marking to help prevent farmers/contractor over-spraying
- Spot spraying for selective herbicide application
- Marking trial plots and strips

**PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND THE ENVIRONMENT:** DO NOT allow chemical containers or spray to get into drains, sewers, ponds or streams. **STORAGE AND DISPOSAL:** Keep out of reach of children. Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemical on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling break, crush, or puncture and bury empty container in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.
